# Code of Behaviour, Health and Safety Contract for Belmont Farm

- Volunteers and work experience students must arrive on time for work each day during their placement, according to their contracted hours. They must arrive clean and presentable wearing the appropriate attire for working with animals on the farm, i.e. wellingtons and jeans, as instructed by their supervisor during their initial visit.
- Before entering and starting work on the farm, volunteers and work experience students must ensure that any cuts or wounds are properly sealed, protected and that any medical conditions are declared to their supervisor.
- When entering and leaving the farm, volunteers and work experience students must wash their hands with disinfectant soap as well as their footwear in the boot wash dips.
- Volunteers and work experience students must report to their supervisor at the start and end of every shift during their placement.
- When addressing any member of the public staff volunteers and work experience students must remain polite and respectful at all times.

#### **Safe Practices & Animal Handling**

- When handling any animals or animal products, feed or when cleaning, volunteers and work experience students must wear suitable protective gloves provided by the farm.
- Upon completion of any tasks involving the handling of animals, feed or cleaning, volunteers and work experience students must rinse and leave their gloves to dry, as well as washing their hands with disinfectant soap.
- When handling animals, feeding, mucking out or cleaning, volunteers and work experience students must not make any contact between their hands and their eyes, mouth or face.
- The use of any knife provided on the farm is permitted for use ONLY in the preparation of feed/vegetables <u>within the store room</u>, but only after its safe use has been demonstrated by a supervisor and permitted. The knife is then never to leave the storeroom.
- When working in any animal pen, volunteers and work experience students must ensure that all gates remain closed at all times and it is their responsibility to ensure that when leaving a pen, for whatever reason, its doors or gates must be closed and padlocked at all times.
- Volunteers and work experience students are only permitted to feed any animal belonging to <u>Belmont Farm</u> administering only the portion directed by their supervisor at specified times and when instructed to do so.
- The use of any cleaning agent, chemical or medicine is prohibited by volunteers and work experience students unless otherwise instructed to do so and upon the reading and completion of the appropriate COSHH forms, where necessary.

#### **Eating & Drinking**

- No eating or drinking, including the chewing of gum, is permitted on the farm at any time.
- If the volunteers and work experience students wish to eat or drink, they may do so either in the restaurant, office or party room.
- The consumption of any animal feed is prohibited and water may only be consumed from those sources indicated by a supervisor to be deemed safe for drinking.
- Any food the volunteers and work experience students wish to bring on to the farm must be for their consumption only during lunchtime and must be properly sealed.
- Before eating or drinking, volunteers and work experience students must wash their hands with disinfectant soap.
- Smoking is prohibited anywhere on the farm at all times.

#### **Working Boundaries**

- Volunteers and work experience students are permitted to work within the boundaries of Belmont Farm.
- Volunteers and work experience students are however, prohibited from passing beyond the gates of Belmont Farm.
- Volunteers and work experience students are prohibited from operating or driving any machinery whilst attending Belmont Farm
